

GENERAL TERMS AND CONDITIONS

1. Scope

The General Terms and Conditions of Business (hereinafter referred to as "AGB") apply in the

current version at the time of conclusion of a contract for all business relations which commercial and private natural and legal persons (hereinafter referred to as "Customers") enter into with GECKO SUPPLY GMBH. They form an integrating and supplementary component for all orders and purchases which are concluded in writing, online or in person.

GECKO SUPPLY GMBH reserves the right to change these terms and conditions. In each case the version of the General Terms and Conditions valid at the time of the order shall apply, which cannot be changed unilaterally for this order.

2. Offers and conclusion of contract

The product range shown online at <https://b2b.geckosupply.com/> does not represent a legally binding offer. The product presentations on the Internet are intended to provide customers with information about a selection of goods from GECKO SUPPLY GMBH and enable customers to submit a purchase price enquiry. They do not represent any obligation on the part of GECKO SUPPLY GMBH to sell and deliver the presented goods. GECKO SUPPLY GMBH may change prices and product ranges at any time.

If the customer places an order via internet, e-mail, mobile, telephone, he/she makes a binding offer to conclude a sales contract.

Confirmation of the order by GECKO SUPPLY GMBH constitutes acceptance of the offer.

3. Availability and delivery time

GECKO SUPPLY GMBH attaches great importance to providing current and accurate information on availability and delivery times in the online shop. However, delays in delivery may occur, particularly due to production or delivery bottlenecks. All information on availability and delivery times are therefore without guarantee and may change at any time.

4. Price

The purchase prices are quoted in Swiss francs, excluding value added tax and excluding packaging and delivery costs. Invoicing shall be based on the price at the time of the order as offered by GECKO SUPPLY GMBH. Packaging and delivery costs are shown separately on the invoice.

5. Delivery, shipping costs

The delivery takes place by sending the object of purchase to the address indicated by the buyer.

Address. Packaging and shipping costs will be charged separately.

The delivery times stated are without guarantee. GECKO SUPPLY GMBH endeavors to deliver the ordered goods as quickly as possible. Delivery of the goods shall be at the customer's expense and risk, even if partial deliveries are made.

6. Payments

Unless otherwise agreed, a payment period of 30 days after invoicing shall apply.

7. Revocation/ Return

There is no right of return or exchange. A return as a gesture of goodwill is solely in the at the discretion of GECKO SUPPLY GMBH.

8. Obligation to check

The customer must immediately check delivered or collected products for correctness, completeness and delivery damage.

In the case of forwarding deliveries, any delivery damage must be noted on the delivery note.

Damage to delivery, wrong and incomplete deliveries must be reported to GECKO SUPPLY GMBH for all products and services within 5 calendar days from the date of delivery.

9. Warranty

GECKO SUPPLY GMBH warrants the product ordered to be free of defects and to function properly for 2 years after delivery. GECKO SUPPLY GMBH warrants the products of the ORTLIEB brand to be free of defects and functional for a period of 5 years. The warranty period shall continue to run regardless of the provision of any warranty services. GECKO SUPPLY GMBH may at its option provide the warranty by

- free repair
- partial and complete replacement by an equivalent used/repaired product
- Replacement by a new product
- Price reduction

10. Data protection

The protection of personal data is an important concern for us. For this reason, we conduct our activities in accordance with the applicable legal provisions for the protection of personal data and data security.
